## Call to Order

Mayor Lilja called the meeting to order at 9:00 a.m.

## **Executive Session**

Motion carried.** 

Mayor Lilja called item #4 Consider Appointment of Chief of Police. Item tabled until the December 4<sup>th</sup> City Council Meeting.

Mayor Lilja called item #5 – Appointment of City Prosecutor. **Motion:** Council President McCullagh made a motion to confirm the mayor's appointment of Ann Henderson as the City Prosecutor beginning today to the term expiring in May 2024. **Second:** Councilmember Best seconded. **Vote: 4-0. Motion carried.** 

Mayor Lilja called item #6 – Consider a Pay Ordinance for the calendar year of 2024. The overall Ordinance for all employees was tabled until the December 4<sup>th</sup> City Council Meeting; however, Council President McCullagh made a **Motion** to approve increasing the part time police officer's hourly rate to \$30 beginning with the first pay period payable in January 2024 and authorize the mayor to sign effectuated Ordinance. **Second:** Councilmember Best seconded. **Vote 4-0. Motion carried.**
