The council requested a more defined scope of the repair work to be performed and how it will tie in aesthetically to the south wall during that phase of construction. Mayor McCullagh indicated he will contact the committee chair and request additional information. **Motion:** Councilmember Zimmer made a motion to approve the bid from Architectural Masonry & Restoration, Inc., in the amt of \$53,750.00, for the bridge repair work and authorize the mayor to sign the agreement subject to clarification regarding the scope of the repair work, liquidated damages, and obtain a certificate of insurance. **Second:** Councilmember Pasley seconded. **Vote: 3-0. Motion carried.**
